Customer waives and voluntarily assumes any and all risk of loss and damage to parked vehicle, personal property or person while on ETA's property.
2. The Customer agrees that ETA shall not be responsible for any loss or damage suffered by the Customer, or to Customer's vehicle (specifically including vehicle windshield and glass) or other property, by theft, fire, accident, acts of God or otherwise and shall not be responsible for any items which may be lost or stolen which Customer may have left in Customer's vehicle. By signing the agreement, Customer hereby waives and releases any and all claims to damage, losses or injury to person and property against ETA, Inc.
3. By signing this form Customer grants permission to ETA, its agents and employees to drive Customer's vehicle to and from DIA (from ETA locations or from Customer's pick-up point) and to and from such other locations as necessary to perform services to Customer's vehicle or on behalf of Customer as Customer shall have directed.
4. Customer agrees to indemnify, defend and hold ETA harmless from any liability or damage resulting from (but not limited to); mechanical failure (including defective brakes) or other defects of the Customer's vehicle, or from any act of the Customer, or their agent, employee or guest.
5. Any claim for damage or loss suffered by Customer, either to Customer's person or to Customer's vehicle or other property, shall be reported, in writing, by Customer to ETA within 24 hours of service of Customer's vehicle.
6. ETA will only be liable to Customer for loss or damage suffered as the result of the negligent operation of a motor vehicle by an agent or employee of ETA acting within the scope of their agency or employer.
7. No shows, after hours and non notification of flight changes will result in additional charges to the customer.
